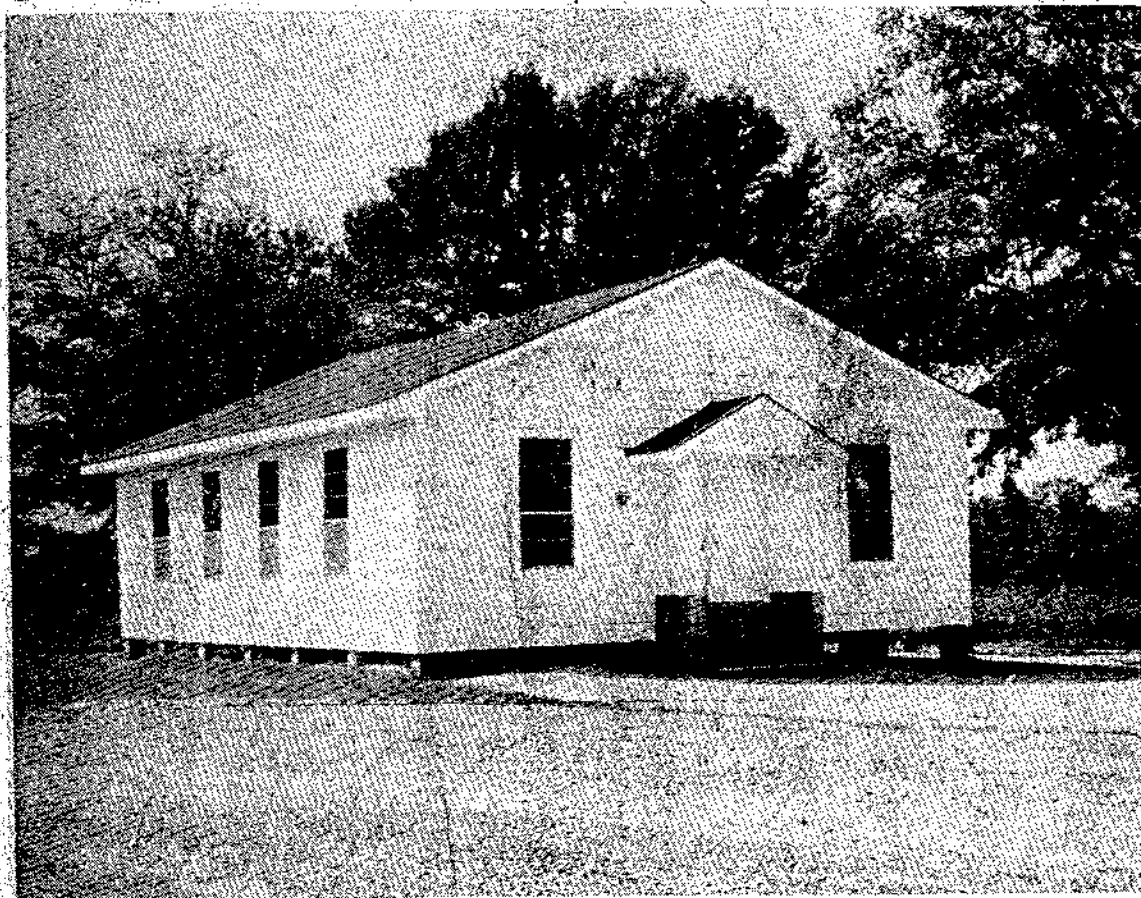


COUNTY LINE CHURCH OF CHRIST 1974

KNOW ALL MEN BY THESE PRESENTS, that I, Callie D. Tindal, for and in consideration of the sum of \$5.00 to me paid in hand by the Church of Christ, the receipt whereof is hereby acknowledged, have this day bargained and sold and by these presents do hereby grant, bargain, sell and convey unto the said Church of Christ the following described tract or parcel of land, to-wit:

Beginning at the S.E. corner of the N.E. 1/4 of the S.E. 1/4 of Sec. 4, T. 9, R. 18 running north 70 yds thence west 70 yds. thence south 70 yds. and thence east 70 yds to point of beginning, containing one acre more or less. Situated, lying and being in the County of Butler, and the the State of Alabama. And it is expressly agreed by and between Callie D. Tindal and T.E. Tindal, J. S. Brown and W.G. Gafford, trustees of the Church of Christ, that the following clause or covenant is inserted in this deed at the request of purchaser, the Church of Christ, and is a part of this deed to be operated and binding forever. This lot is to be used for the benefit of the Church of Christ, holding aloof from all things in the work and worship of all things not taught in the New Testament scriptures. That is to say, no society, organization, whatever for religious work, worship or service, other than the Church of Christ shall meet on or in any building erected on this lot. No music shall be used other than singing, nor methods of raising money adopted by the said church using this property not laid down by apostolic precept or example in the New Testament; all entertainments except the Church in its worship, are excluded from the use of this property. Should this Church or any part of it ever depart from these conditions, the title of this property is immediately invested in the member or members whether many or few, and adhering to the above mentioned conditions. If every member of this church depart from these conditions, then the title of this property shall immediately vest in the Church of Christ nearest to this, which holds to the conditions set forth in this deed.

To have and to hold the same unto the said T.E. Tindal, J. S. Brown and W.G. Gafford, their heirs, executors, administrators and assigns forever, in fee simple.
