This lot is to be used for the benefit effithe Church of Christ, holding aloof from all things in the work and worship of all things not taught in the New Testament scriptures. That is to say, no society organization, whatever for religious work, worship or service, other than the Church of Christ shall meet on or in any building erected on this lot. No music shall be used other than singing, northethods of raising money adopted the said church using this Chuperty not laid down by apostolic precept or example in the New Testament; all entertainments except the Church in its worship, ere excluded from the use of this property. Should this Church or any part of it eyer depart from these conditions, the title of this property is immediately invested in the member or members whether many or few, and adhereing to the above mentioned conditions. If every member of this church depart from these conditions, then the title of this property shall immediately vest in the Church of Christ nearest to this, which holds to the conditions set forth in this deed.

To have and to hold the same unto the said T.E.Tindal, J. S. Brown and W.G. Gafford; their heirs, executors, administrators and assigns forever, in fee simple.

Brown and W.G.Gafford, trustees of Church of Christ, that we are seized in fee of the afore granted premises and have the right to sell and convey the same; and we do hereby warrant the title to the afore granted premises and agree forever to defend the same from the lawful claim of all persons whatsoever.
